Conflicts prevent effective measures for fighting COVID-19



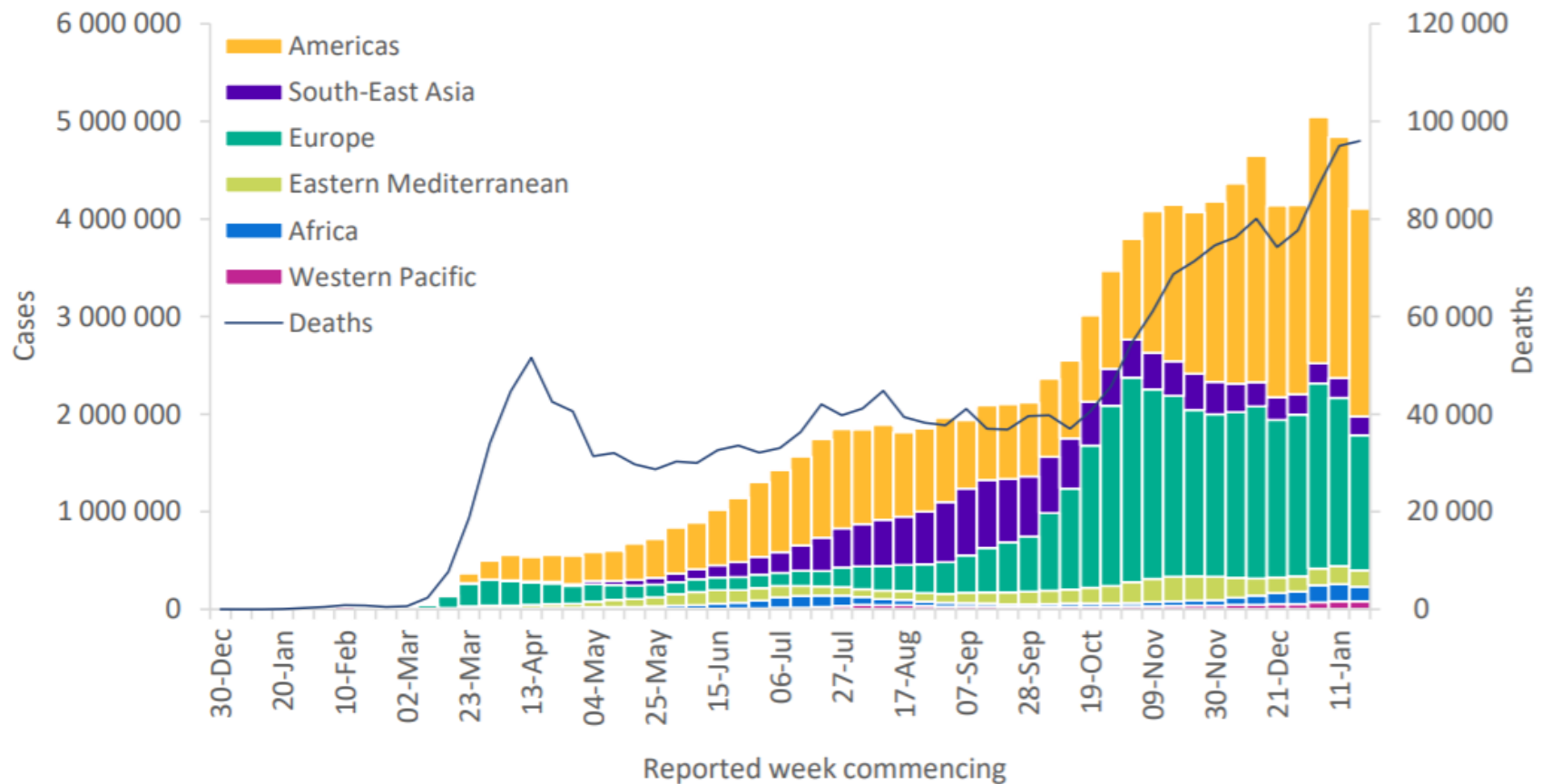
Backlash against globalization; growing international cooperation on public health

Figure 1: COVID-19 cases reported weekly by WHO Region, and global deaths, as of 24 January 2021**

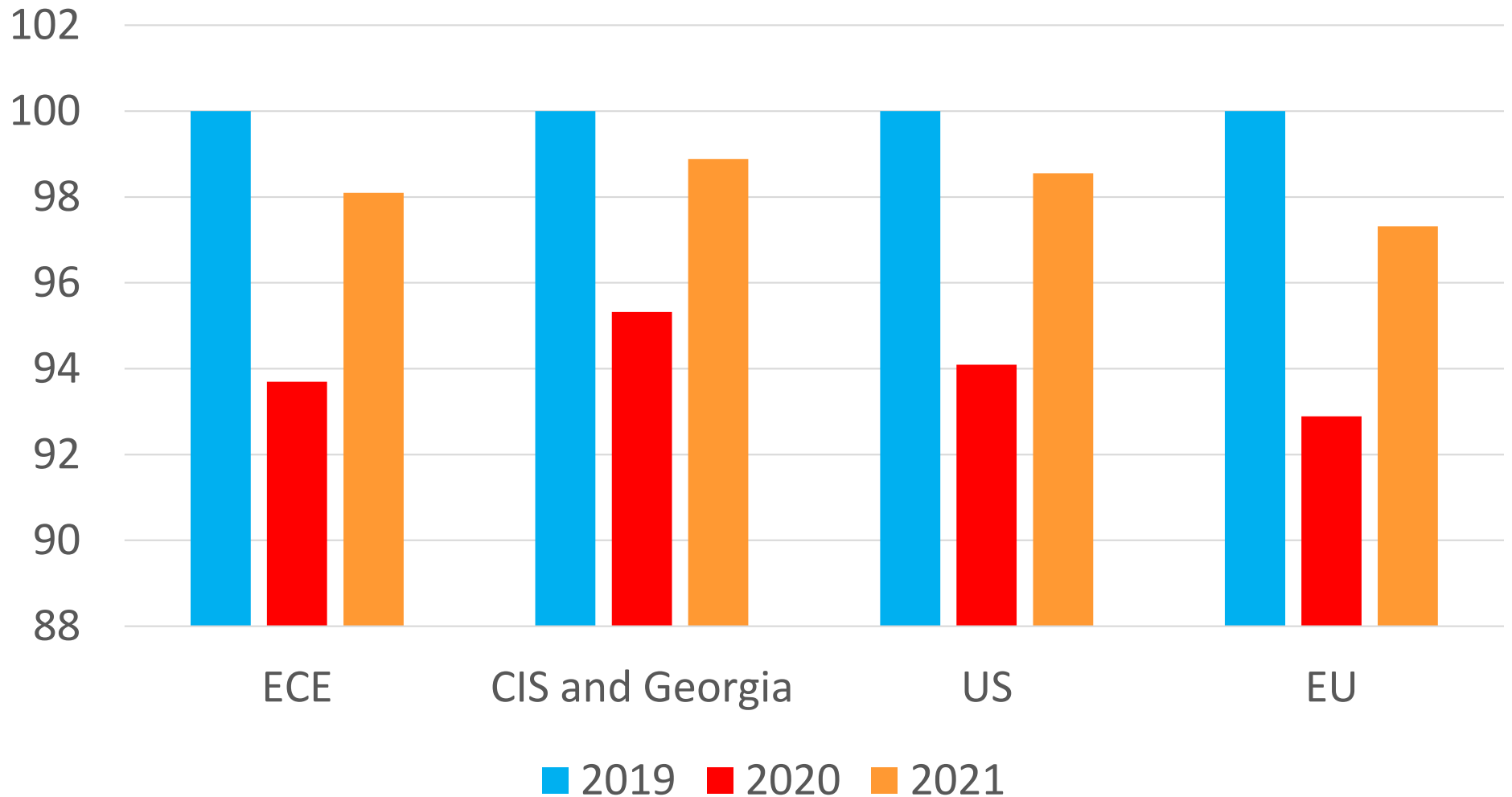

Projected GDP levels, 2019=100

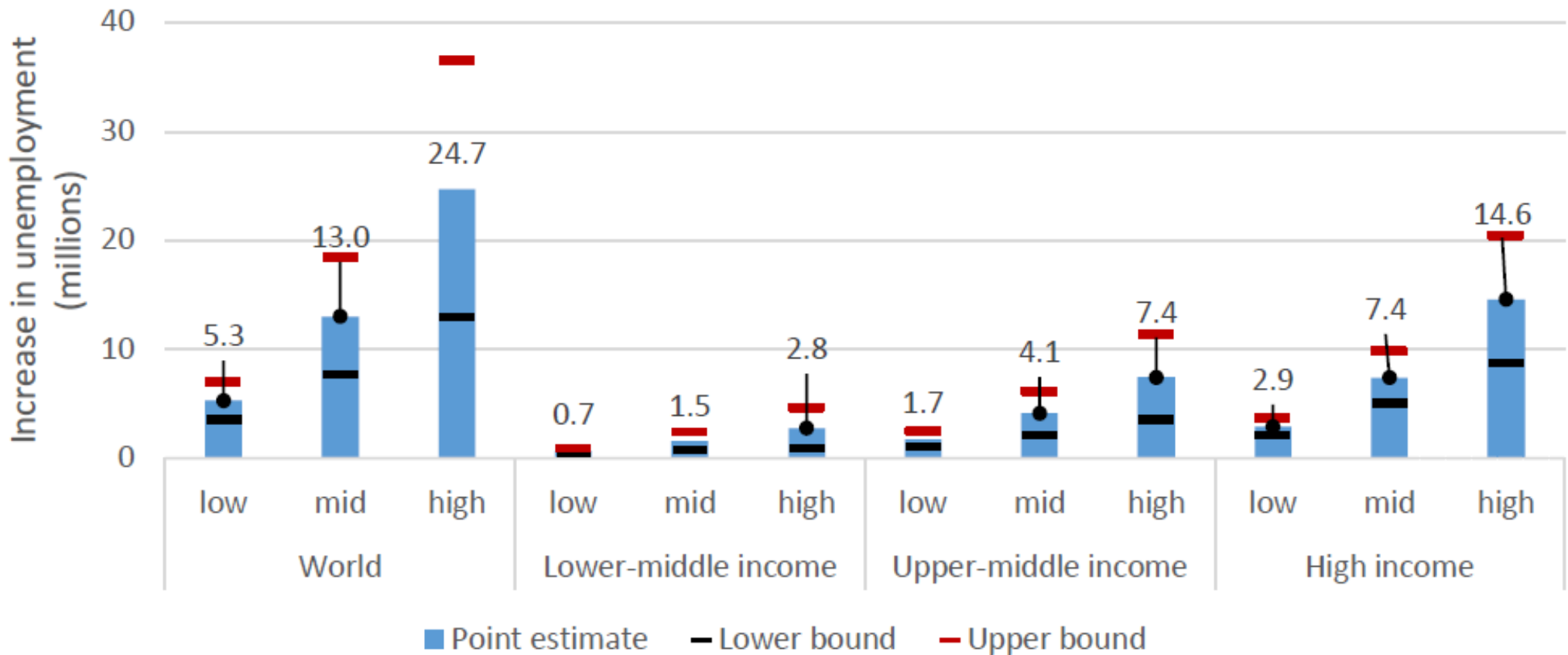

UNECE increased engagement at the regional and country levels




- The **SG report** on the COVID-19 response : importance of **regional coordination** and the preservation of **connectivity**
- UN framework for the **immediate socioeconomic response** is based on five pillars
- Emphasis on **integrated, coordinated** interventions that are **aligned with SDGs**

Pillars of the UN Development System Response

1  **HEALTH FIRST:**
Protecting health services and systems during the crisis

2  **PROTECTING PEOPLE:**
Social protection and basic services

3  **ECONOMIC RESPONSE & RECOVERY:**
Protecting jobs, small and medium-sized enterprises, and the informal sector workers

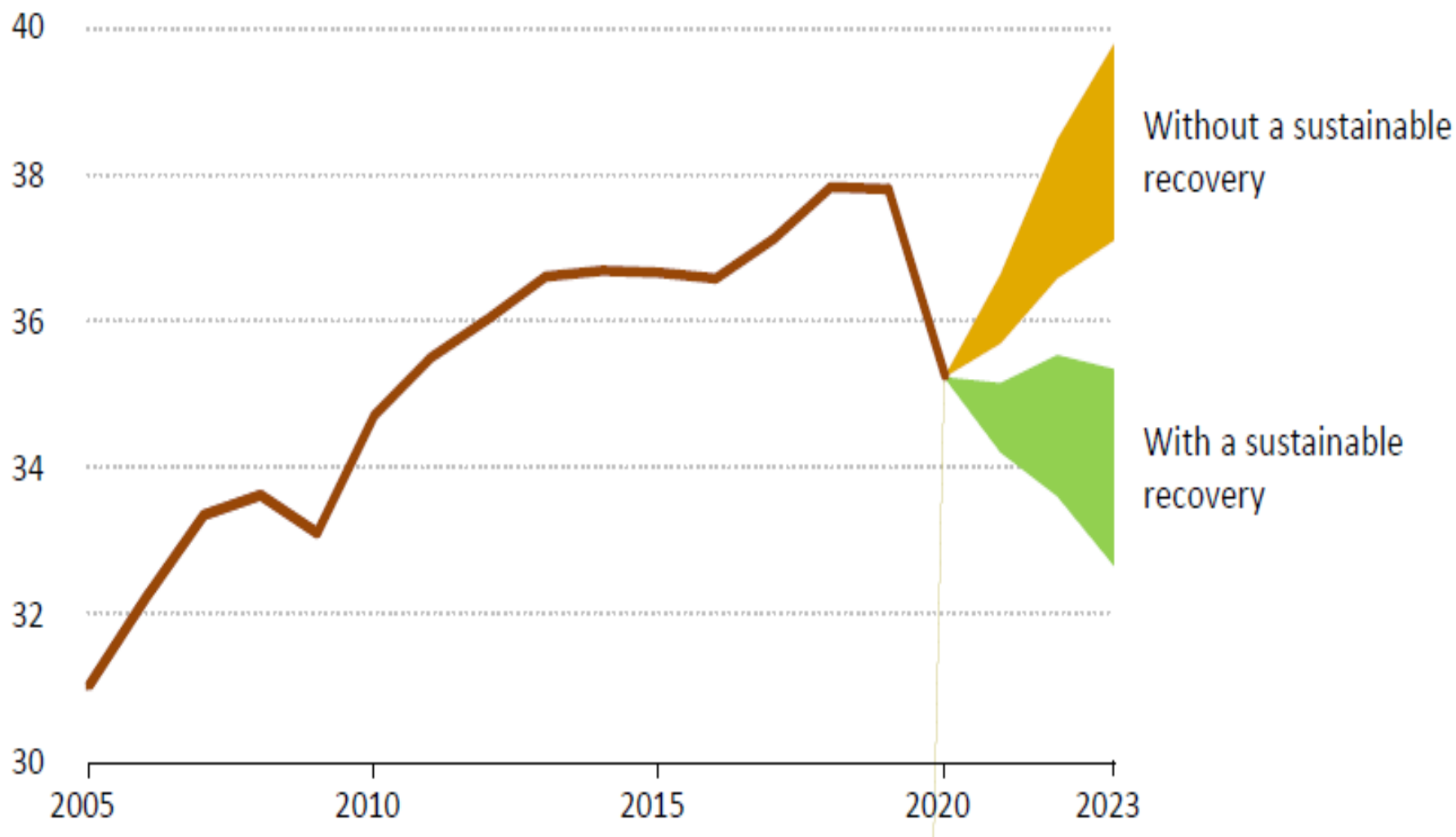
4  **MACROECONOMIC RESPONSE AND MULTILATERAL COLLABORATION**

5  **SOCIAL COHESION AND COMMUNITY RESILIENCE**

What needs to be done?

- **Reduce uncertainty** – This is the time to re-commit to existing frameworks for cooperation. Trust on concerted action must be strengthened.
- **Re-build** – Persistent economic damage is likely, requiring continued policy support. This reconstruction agenda needs to connect with the green transformation and the SDGs.
- **Re-connect** – The disruption to trade and transport needs to be addressed.
- **Re- think-** New approaches for resiliency and efficiency, such as the circular economy, should be used
- **Regionalise-** As globalisation is being eroded, the prominence of the regional level to deal with cross-border problems will increase
